1. Robert Finnamore – Odell Road – S-5-2016

Katelyn Hayden presented Planning Staff Report #18/16 notifying that Robert Finnamore has applied for approval of a tentative plan of subdivision to create a lot accessed by a 9m wide private right-of-way on property identified as PID #65025140 located on the Odell Road in Odell.



Katelyn Hayden reviewed with the members and circulated an aerial photo showing the approximate location of the lot. Katelyn Hayden advised the surveyor has indicated that the owners of the proposed lot intend to use the private Odell Road to access the private access, which crosses the parent PID. Katelyn Hayden advised the final plan will not be approved until the access has been established and if right-of-way is not granted by the existing camp owners of PID 65210536 over Odell Road an amended plan will be resubmitted to PRAC for approval.

Katelyn Hayden noted since the existing camp and shed are located within the 30 metre buffer of a regulated wetland and any future construction or soil disturbance on the lot would require a WAWA permit.

Katelyn Hayden advised since the proposed lot meets and exceeds subdivision lot area requirements and adequate private access has been proposed, staff are prepared to support the application subject to the documented terms and conditions listed in Planning Staffing Report #18/16.
