should be mapping Mt. Carleton connections, as there is no decision on this topic. Neil has estimated a cost of \$700 to have the mapping developed for the website.

It was moved by Craig Melanson and seconded by Brent Pearson to approve the \$700 for the development of the website pages.

Handheld GPS- Neil explained that there is a need for a GPS to locate trails, boat launches and other features for the mapping. Staff have been using their cellphones for this task; however, cellular service is not available is some of the areas. The committee discussed whether \$200 was sufficient funds to purchase a good quality device. It was determined that \$200 was not sufficient for what staff felt they required.

It was moved by Kent Kuhn and seconded by Chris Stacey to approve staff to spend \$400 on the purchase of a handheld GPS device.

**Semi-Annual Newsletter-** Neil Antworth discussed with the committee the best timing for the release of the first newsletter. It was determined that late fall would likely be the best option, capturing the regions winter events and programs. It was suggested that a partnership with the Bugle Observer to highlight some of the regions events should also be pursued.
