Q1 Financial Report

The first order of business was the presentation of the first quarter financials by Finance Manager, Joan Kennedy. Joan explained the reports and each mandate budget separately. Joan and Katelyn provided explanations and answered questions from the Board of Directors regarding the budgets, expenditures, and the mandate expectations.

Update on Meal and Mileage Rates – Katelyn reported that the provincial rates have been updated as we follow the Government of New Brunswick's Mileage and Meal policies. This was explained for information purposes only as there will be an impact on the budget mainly for mileage that is going from \$0.50/km to \$0.57/km.

ESIC – Katelyn explained the changes and amendments to the ESIC MOU

- a) Updating the term of the MOU that was signed in 2022 to extend it to March 31, 2025 is necessary to access the fund from ESIC
- b) Slight increase in the funding amounts that will flow to the RSC
- c) change in wording to allow us to use our own MOU created by our lawyer and not the template sent by ESIC

Regional Tourism

Katelyn also extended a message from Barb Sharp asking the Board to make certain that the Mayors and Councils are aware of the upcoming Eclipse on April 8, 2024, and to consider how they wish to direct the commission to support municipalities in this endeavour. Barb will be asked to provide an update on what is happening in the region at the June 21 meeting of the Board.

Summer Student – The WVRSC has been approved for a 50% wage grant from Canada Summer Jobs.

CEO Update

Katelyn mentioned that she has attended two meetings with Minister Jill Green, the Minister of Service New Brunswick and the Minister responsible for Housing. We will await the province to create their Housing Strategy which is to be delivered in July 2023. This will help determine the RSC's involvement in the Housing mandate. We will eventually need a Housing Strategy done for our region as well, and the province has yet to determine where the funds for this regional study will come from.

Katelyn mentioned that another meeting was held to discuss the Transportation mandate and related issues and barriers, including the inability of our most vulnerable residents to travel to work, and a potential opportunity for partnerships with employers to address these transportation/employment concerns. The provincial government would like to have an integrated system of organizing transportation, as well.
