For consideration to approve a subdivision application to create two separate lots currently owned by the Department of Education: one to accommodate the existing municipal pool and the other for a proposed daycare facility to be owned and operated by Step Ahead Inc.

The Planning Director, Conor Tripp, advised that to proceed with the subdivision application, School Street must be extended to ensure legal public access is available for both proposed lots.

Conor Tripp presented Planning Staff Report PR # 11/25 while displaying site plans, parking areas, preliminary layouts of the subdivision including School Street Extension, proposed daycare floor plan, existing school and the former school locations in relation to the proposed School Street extension, subdivision tentative plan. Excerpts from the Village of Bath Rural Plan – Institutional Zone, as it relates to the application were read.
